Since 1974 the Medical Center has provided medical services to the Ocean Reef Community. Initially established as a two-physician primary care facility, it has evolved into a medical facility that few private communities can offer. The security of knowing your medical care is a golf-cart ride away is priceless.

The Medical Center's Mission is "To provide caring and professional medical services and health education to the Ocean Reef Community." Towards that end, the Medical Centers offers patients the best and most complete health care possible within the gates of Ocean Reef. The Medical Center is staffed with 4 full-time physicians and an ever expanding visiting specialists program. Also offered to those interested, are two Private Medicine programs. Diagnostic services include an MRI, CT scanner, ultrasound and digital X-ray along with Coolsculpting. If higher care is required the Medical Center has a close working relationship with Baptist Health South Florida in Miami and Homestead.

Health education opportunities are offered throughout the seasonal months and include the popular "Night's Out" and "Medical Lecture Series"; offering recognized speakers that are top in their field from renowned institutions such as M.D. Anderson, Cleveland Clinic, Bascom Palmer and more.

Insurance reimbursements in today's healthcare are woefully inadequate and only cover about a third of operating costs. We need the support of the Ocean Reef Community. The yearly fund raising events, such as the All Charities, Boutique D'Reef and the annual "Fun-Raiser contribute greatly but it is the Founders Society that provides a yearly base for the Ocean Reef Medical Center Foundation's endowment and enables the continuance of the important mission to "Provide the Best Health Care Possible".

We sincerely thank all of our Founders and contributors for their generosity and appeal to everyone in the Ocean Reef Community to generously support the Medical Center in any way that you are able.
