# CHAIRMAN'S MESSAGE

## DEAR MEMBERS

This annual report marks 41 years that the Medical Center has been providing medical services to the Ocean Reef Community. We are so very proud to announce the recent 2015 achievement of earning the American Association of Ambulatory Health Care (AAAHC) accreditation. This is a big accomplishment. Nationwide only 5,000 facilities are awarded the AAAHC designation and not all that make application can pass this high standard mark.

The Medical Center has kept pace with growing medical technology and the demands of an aging population. With that growth has come better care, faster service and connections with the greater Miami medical community. The Medical Center may be the only private community offering such varied and complete health care.

Just as the membership and activities of the Reef has grown over the past 9 years, so has the Medical Center's patient volume and services.

The Medical Center's building is no longer used in the same fashion as anticipated when it was built. Since opening its doors in November of 2006 there have been many services added and a huge increase in patient visits - now over 20,000 encounters a year.

A committee was formed to explore the possibility of expansion rather than a redesign, due to lack of space. After discussion with the staff and respective departments, along with the engagement of the original architect Luis Naya, it was decided that an expansion was feasible and very much needed to accommodate the growing demands of Ocean Reef.

The total expansion will be approximately 8,100 square feet of new space and 4,200 square feet of renovated space. The cost of the expansion will be funded from a capital building campaign so as not to take monies away from existing Foundation funds.

The anticipated start date of this project will be April of 2016 and when complete will provide the following improvements:

- Additional exam rooms for primary care with a new relocated nurses' station with several rooms incorporating telemedicine abilities.
- The very busy laboratory will be relocated to address the high volume service with greater efficiency.



- Additional dermatology suites will allow for more dermatology visits with designated equipment.
- Specific rooms for ophthalmology with new and advanced eye testing equipment.
- Expanded physical therapy to improve patient privacy and establish specialty care areas for hands, back, shoulders, balance and gait.
- All imaging will be located in one section of the building and the second original treatment room will be returned to its original function.
- Imaging capabilities will be expanded with the addition of an MRI machine that has been totally funded by several very generous donors, including five years of maintenance costs. Due to this philanthropy, this new program will be cash flow positive. Now patients will have access to the most advanced diagnostic services without leaving Ocean Reef.

Our mission is to provide the best, most complete health care and education possible right here at Ocean Reef. To accomplish this we must have the support of the Ocean Reef Community. The yearly fund raising events greatly contribute, such as the All Charities, Boutique D'Reef and the "Fun-Raiser". Of particular importance is our Founders Program that provides a yearly base for the Ocean Reef Medical Center's Endowment. Insurance reimbursements in today's healthcare are woefully inadequate and only cover about a third of operating costs.

We sincerely thank all of our Founders for their generosity and appeal to everyone in the Ocean Reef Community to generously support the Medical Center in any way you can.
