- 65 years and older
- 18+ who have underlying medical conditions
- 18+ who work in high-risk settings
- 18+ who live in high-risk settings

PEDIATRIC CARE:

Pediatric Care at The Medical Center is now supported by Nicklaus Children's Hospital partners. Helmed by Rosa Monte-Fernandez, M.D; Pediatric Preventive, Comprehensive and Wellness services are available at MCOR. In addition to being an on-site Visiting Specialist: Dr. Monte-Fernandez is also available for scheduled telehealth appointments.

Parents of minors, we invite you to establish care with Dr. Monte-Fernandez. Her contact information and registration forms can be accessed via MOCR.org. Also of note, for those of you who have not yet secured flu vaccinations for your children; do not hesitate to give us a call to confirm your child's appointment.

As Flu season approaches, the CDC recommends children 6 months through 8 years of age who are receiving influenza vaccine for the first time or who have received only 1 dose before July 1, 2021, or whose vaccination status is unknown, should receive 2 doses of influenza vaccine 4 weeks apart, ideally by the end of October.

FLU SEASON: What's New for 2021-2022

A few things are different for the 2021-2022 influenza (flu) season, including:

- Annual flu vaccination is recommended for everyone 6 months and older, with <u>few exceptions</u>.
- The composition of flu vaccines has been updated.
- All flu vaccines will be quadrivalent (four component), meaning designed to protect against four different flu viruses. For more information: Quadrivalent Influenza Vaccine | CDC.
- Licensure on one flu vaccine has changed. Flucelvax Quadrivalent is now approved for people 2 years and older.
- Flu vaccines and COVID-19 vaccines can be given at the same time.
- More detailed guidance about the recommended timing of flu vaccination for some groups of people is available.
- Guidance concerning contraindications and precautions for the use of two flu vaccines Flucevax Quadrivalent and Flublok Quadrivalent were updated.

In Other News:

Merck said Monday it is seeking US Food and Drug Administration emergency use authorization (EUA) for its experimental antiviral Covid-19 treatment, molnupiravir. If authorization is granted, the drug, made by Merck and Ridgeback Biotherapeutics, would be the first oral antiviral treatment to fight Covid-19. It comes in capsule form.

"At the interim analysis, molnupiravir reduced the risk of hospitalization or death by approximately 50%; 7.3% of patients who received molnupiravir were either hospitalized or died through Day 29 following randomization, compared with 14.1% of placebo-treated patients, "the company said in a statement.

Data from the trial has not yet been peer-reviewed or published. At a White House Covid-19 briefing last week, Dr. Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases, called the trial results "very encouraging," but said the drug needs close scrutiny by the FDA.
